NO STUDENTS WILL BE ADMITTED LATE NOR WILL TICKETS BE REFUNDED!

- Mira Costa Administrators and Staff reserve the right to end the event early if liquor is present at the event. (It is unlawful for minors to consume or possess alcohol.)
- 8. California Education Code 48900(q) specifies that a pupil may be suspended or expelled for acts related to substance abuse that occur while on school grounds, and traveling to or from a school-sponsored activity. When one is engaged in a school-sponsored activity, the following consequences will apply to any students found in possession and/or under the influence of alcohol, controlled substances, or look-alike substances, or involved in any type of fighting, theft, vandalism, or defiance of authority. By signing this form, all dance attendees and parents agree to submit to a breathalyzer test if requested by the administration (either randomly or specifically).

In the event of student/guest misconduct, the Principal/Principal's designee (any members of the Chaperone group) will immediately attempt to notify parent(s)/ guardian(s) about the nature of the infraction and the consequences.

Any student in possession of illegal substances is subject to arrest. Appropriate disciplinary action will occur at school the week after Prom.

- ** MCHS Administration encourages parents to prohibit pre-dance parties that permit the consumption of alcohol or other illegal substances as this type of party increases the student's chance of having problems during the event and may put the party host in a vulnerable legal position
